The owner shall forthwith remove any excrement of such dog or cat. Any unruly dog or cat shall be removed after written notice by the council. This bylaw may not be amended except by unanimous resolution of the Owners."

The pet bylaw is the only bylaw that will be open for discussion at this meeting, with the exception of changes required in 3a for Strata Property Act compliance.
